PIKE COUNTY BOARD OF COMMISSIONERS**

The Pike County Board of Commissioners held its Regular Monthly Meeting on Wednesday, November 9, 2022, at 9:00 a.m. in the Courthouse, Main Courtroom, at 16001 Barnesville Street, Zebulon. Chairman Briar Johnson convened the meeting and Commissioners Tim Daniel, Tim Guy, Jason Proctor and James Jenkins attended. County Attorney Rob Morton and County Clerk Angela Blount were also present. (O.C.G.A. § 50-14-1(e) (2)). County Manager Brandon Rogers was not present.

- f. Adoption of the Pike County and Cities Joint Comprehensive Plan 2022-2042.

Planning and Development Director, Jeremy Gilbert, addressed the Board stating this is the final step in the Comprehensive Plan update. The Comprehensive Plan kicked off on January 25, 2022, with the first Public Hearing where the Steering Committee was set up. The Steering Committee along with Staff met monthly with Three Rivers to gather information available to put this plan together. On June 20, 2022 was the first public open house inviting the public to come out and provide information on how they would like to see Pike County grow. On September 27, 2022 it was brought to the Board of Commissioners for the final public hearing and the transmission of the Comprehensive Plan to Three Rivers RDC and Department of Community Affairs, DCA, for review and approval. On October 26, 2022, Three Rivers RDC received the review back from DCA stating the plan meets and addresses the minimum planning standards for local comprehensive plan and the plan can now be adopted. County Mananger Rob Morton reiterated that there was a lot of work put into this plan; Jason Leatherman is present and part of the process on the new Planning Zoning Board, Chairman Briar Johnson and Commissioner Jason Proctor were a part of the meetings. A lot of people were involved, good job.

Motion/second by Commissioners Daniel/Guy to approve the adoption of the Pike County and Cities Joint Comprehensive Plan 2022-2042 and authorize Chairman Briar Johnson to sign, motion carried 5-0.
